Acknowledgement

By signing this form, you acknowledge that you have read and understand the club by-laws and that you will abide by the same. Additionally, signing of this form is giving the Head Coach, Columbus Soccer Club (CSC), permission to contact parents of former players that you may have coached, whether from a team within CSC, or a team belonging to another organization. Your signature certifies that you further understand that CSC officials may conduct a limited background investigation, above and beyond that check conducted by the Nebraska State Soccer Association, for the purposes of assuring that no individual who has been convicted of a charge of moral turpitude, or a felony, is awarded a club coaching position. You may withdraw your consent for the actions described above at any time; however, doing so may result in the denial of your application. If you withdraw your consent for background checks after approval of the application, the club may withdraw that approval at any time during the probationary period described below.

Your signature certifies your understanding of, and your agreement to comply with, the requirement to complete the necessary course of instruction for a U.S.S.F. "F" certificate within three (3) years of the date that you are approved as a coach, and an "E" license within five (5) years. Failure to obtain the necessary license within the prescribed time frame may result in your removal as a club coach. Licenses or diplomas issued by an organization other than U.S.S.F. may be considered on a case-by-case basis by the Head Coach.

If your request is approved you will be required to serve as a probationary coach for a one (1) year period from the date of approval. Probationary coaches may be relieved of duties without notice, based on a reasonable suspicion of activity requiring dismissal.
